Terms & Conditions

1. By participating in the Offer, you accept these terms.
2. In these terms, a reference to **you, your** or a **Participant** is a reference to the individual participating in the Offer.

Offer Overview

3. The Refer a Friend Offer (**Offer**) allows existing Spacetalk customers (**Referrers**) to refer new customers (**Friends**) to purchase Spacetalk products and receive rewards as set out in these terms.

Eligibility & Entry

4. To participate as a Referrer, you must:
 - have previously purchased a product from Spacetalk; and
 - provide a valid name and email address to receive your unique referral link.
5. To qualify as a Friend, the referred person must:
 - be a new Spacetalk customer (no prior purchases);
 - make a purchase of smartwatches and/or accessories on spacetalk.co;
 - spend a minimum of \$100 (excluding delivery fees and before application of the referral discount); and
 - use the referral code provided via the Referrer's unique link at checkout.

Referrer Rewards

6. When a Friend completes a qualifying purchase, the Referrer will receive the Referrer Reward via email.
7. The Referrer Reward is subject to a 30-day validation period from the date of the Friend's purchase. The reward will only be issued if the Friend's order is not refunded or cancelled within this period.
8. The Referrer Reward:

 - can only be used on smartwatches and accessories purchased via spacetalk.co;

 - can be stacked with sale pricing; and
 - cannot be used in conjunction with other discount codes unless expressly stated.
9. Referrers will receive a reminder email 48 hours before their Referrer Reward expires.

Friend Rewards
